**Subject:** WFHOA Board of Directors Meeting:

**Call to Order:** The Board of Directors meeting was called to order at 7:03 PM at the First Baptist Church on Wickham Road. Proper notice was given.

**Determination of a Quorum:** Board members present were Lane Smith, Nancy Phillips, Duane Charter, Mary Greenfield, and Ed Clark.

**Board Meeting Minutes:** The minutes from the January 2011 meeting were approved as published in the newsletter.

**Treasurer's Report:** The treasurer's report was read and approved. It will be published in the newsletter. There are 46 homes that have not paid their 2011 assessments.

**2<sup>nd</sup> Vice President's Report:** There were 4 letters sent out this month: 2 sent to 2670 Forest Run Drive, and 2 for a trailer on Forest Run Drive. There were approximately 90 violation letters sent out in the last six months for garbage violations.

### **Council Member Mike Nowlin Visit:**

• Mike Nowlin, Melbourne Council Member for District 1, attended the meeting to discuss issues with the community. He informed us that Red Maple is not on the current repair list. It has been inspected, but because the French drains near the curbs need to be replaced and the hard-pan, the street will need to be dug up and replaced. That is a large expense that must be budgeted for. During the traffic survey on Forest Run drive, there were 26 citations issued for traffic violations.

The County is again reviewing traffic on Wickham Road. People concerned are urged to contact Mary Bolin's office to discuss the issue. Her number is 321-633-2044.

### **Old Business:**

- Conservation Area Update: It is looking very good in the area. 2nd spraying was done last week. They sprayed along the fence again and also sprayed some pepper trees in the area. The next spraying will be in April. After the April spraying, we can schedule to plant new vegetation in the area. We are hoping to get homeowners to volunteer to help with the planting in the area.
- The next group of storm water repairs should start in March 2011.

Bike Path update: The trees have been trimmed back and the area is now well lit again. The homeowner in that are mentioned that Arbor Tech did a very good job.

### **Election Results:**

- The Board of Directors continue to be Nancy Phillips, Mary Greenfield, Lane Smith, Ed Clark, and Duane Charter.
- The Proposed budget passed 157 to 5.
- Issue to request the city to investigate speed humps: Failed with 81 to 81 vote. The information will be passed to the city, but no further action is expected.

Adjourned: The meeting was adjourned at 8:20 PM.

FLORIDA NOW NUMBER ONE IN STAGED AUTO WRECKS

The National Insurance Crime Bureau (NICB) says Florida now holds the top spot in the county in questionable insurance claims for what appear to be staged accidents. The number went up 77% in the first half of last year staged accidents. The number went up 77% in the first half of last year compared with the same period in 2009. The prime spots for the crime in the state are Tampa, Orlando and Miami, but it's been increasing in Palm Beach County at an alarming rate. Suspected staged accidents in West Palm ? Beach surged from 50 in 2008 to 96 in 2009. The reason staging an accident is so lucrative in Florida is the state's personal injury protection § (PIP) law, which pays up to \$10,000 in medical claims for a person injured in an accident without having to determine fault, a requirement in most states.

Florida Chief Financial Officer Jeff Atwater has pledged to toughen the law to reduce fraud and put criminals who commit it in jail. But proving an insurance claim is a scam recently got harder when the Florida Supreme \$ Court struck down insurers' ability to require people suspected of fraud to answer questions under oath and submit to an independent medical exam. The NICB's operations director, Ron Poindexter, who also is a former director of the Florida Division of Insurance Fraud, also is lobbying for a \$

### **WELCOME NEW RESIDENTS**



The board would like to welcome any new residents to our community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member. We will be happy to assist you in any way we can.

A few reminders regarding our Covenants, for those who do not have a copy —

- 1. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Big piles of yard debris are difficult to handle and will not be picked up. Yard debris not picked up on Fridays will require that the homeowner call Waste Management themselves to arrange for a special pickup at no cost to the homeowner. It is suggested that the homeowner also call a board member to notify them that a pickup has been scheduled. For information, contact Waste Management at 321-723-4455.
- 2. <u>Garbage is picked up on Tuesdays and Fridays</u>. Recycling is picked up Wednesday. Garbage containers/recycling bins should not be placed at the curb until 5pm the night before pick up. Garbage containers/recycling bins must be stored as not to be visible from the street or adjacent property within sight distance of the lot.
- 3. If you are planning to paint your home or plan any exterior changes, please contact the Architectural Review Committee (ARC) for approval **BEFORE** starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval.
