TRASH BIN VIOLATIONS COMING...



In August 2010, new trash containers were distributed to the homes in Wickham Forest. Starting with the August 2010 newsletter, we have stressed that the bins must be stored out of site. By now you should have made arrangements to store your new trash cans out of site.

Note that per Section 7.5a of our covenants, trash may not be placed curbside before 5 p.m. the day before scheduled pickup.

When yard trash was picked up on Mondays, the board was lenient in enforcing this covenant because the spirit of the covenant is not meant to penalize homeowners who are trying to maintain their property. As most homeowners do their yard work over the weekend, allowance was made so that yard trash placed curbside over the weekend was not enforced as a violation. With yard trash pickup now on Fridays, the board can no longer be as lenient, or the neighborhood will have yard trash curbside for most of the week throughout the year. The board realizes this is going to be inconvenient, but yard trash will not be allowed to be placed curbside until Thursday evening once the program begins.

Those homes that have not made arrangements to properly store the bins have received warning notices.

To date, there have been 84 violation notices sent out. Repeat offenders will be receiving a fine in accordance with the covenants. Please work with us in the effort and store your trash bins out of sight.

Subject: WFHOA Board of Directors Meeting:

Call to Order: The Board of Directors meeting was called to order at 7:00 PM at 4245 Wood Haven Drive. Proper notice was given.

Determination of a Quorum: Board members present were Nancy Phillips, Duane Charter, Mary Greenfield, and Ed Clark.

January 2011 Minutes: The minutes from the October 16, 2010 meeting were approved as published in the newsletter

Treasurer's Report: The treasurer's report was read and approved. It will be published in the newsletter. The lawn at a home on Forest Run was mowed at WF expense. The homeowner will be charged and a fine assessed.

2nd Vice President's Report: There were 89 violation letters sent out since the October 2010 meeting. 84 of the letters were for garbage can violations. We will be posting an article in the next newsletter and start sending fines to violators.

Old Business:

- Bent Pine Lake and fence: The fence along the Bent Pine retention pond and Sherwood has been completed and the lake culverts repaired.
- Wickham Forest Storm water system repair: We still have to complete repairs on structures 99, 132, 134, and 144. (Note: the BSE report and pictures are available on the Wickham Forest website).
- The bike path at the end of Forest Run has been repaired. A motion was made, seconded, and passed to spend \$400 to have Arbor Tech trim the trees that are blocking the light over the path.
- Conservation Area Update: The second spraying will be completed in late January or early February. There is 1 pepper tree that will need to be sprayed. After the next spraying, we will have the area box graded. In the early spring, we will be looking for volunteers to help plant shrubs in the area.
- Conservation Area Fence Lawsuit: There is a hearing at the end of January. We expect the lawsuit to be dropped at that time.

A home on Forest Run Drive has penalties and fines totally $^{\sim}$ \$2500. A motion was made, seconded, and pass to turn the issue over the attorney if not paid by February 15th.

New Business:

- The fence between Wickham Forest subdivision and the railroad is in need of repair. Replacing the fence would cost about \$9000 and will need to be budgeted in the future. Ed will contact the fence company and investigate repairing the fence.
- The Annual Homeowners meeting is scheduled for February 24th at the Church.
- A motion was made, seconded, and passed to appoint Georgette McWilliams as the Neighborhood Watch chair-person. She requested that anybody with ideas or willing to assist please contact her.
- We have been contacted by Councilman Nowlin concerning the traffic problem at the entrance to the subdivision.

A motion was made, seconded, and approved to give the ARC Chairperson a Christmas bonus every year. The amount of the bonus will be determined by the Board.

Adjourned: The meeting was adjourned at 8:30 PM.

The board would like to welcome any new residents to our community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member. We will be happy to assist you in any way we can.

A few reminders regarding our Covenants, for those who do not have a copy —

- 1. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Big piles of yard debris are difficult to handle and will not be picked up. Yard debris not picked up on Fridays will require that the homeowner call Waste Management themselves to arrange for a special pickup at no cost to the homeowner. It is suggested that the homeowner also call a board member to notify them that a pickup has been scheduled. For information, contact Waste Management at 321-723-4455.
- 2. <u>Garbage is picked up on Tuesdays and Fridays</u>. Recycling is picked up Wednesday. Garbage containers/recycling bins should not be placed at the curb until 5pm the night before pick up. Garbage containers/recycling bins must be stored as not to be visible from the street or adjacent property within sight distance of the lot.
- 3. If you are planning to paint your home or plan any exterior changes, please contact the Architectural Review Committee (ARC) for approval **BEFORE** starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval.
