## **SCAM WARNING**

We recently received this warning notice from Phil Archer, State Attorney for Brevard and Seminole Counties.

As State Attorney for Brevard and Seminole Counties, I am informed daily of criminal activity in our counties. I pay close attention when a particular crime appears to trend at an increasing frequency. One such criminal fraud has come to my attention in the last month. If you have a business or club house, I have also attached a flyer which you can hand out to customers or display prominently in case any of them are being preyed upon by these unscrupulous criminals.

Here is how the scam works:

The call comes out of the blue. It's a flustered sounding woman, crying. The first words out of her mouth are "Poppa, it's Sandy. I'm in trouble" and she sobs. Immediately, the grandfather is on red alert. His granddaughter is in trouble.

The details vary, but usually the tale of woe is unfolding in either a foreign country or a remote state where the vacationing young woman or man has met with mishap—an accident, an injury, an arrest—and there is an immediate need for money for bail, doctors, rental vehicles. And Poppa springs into action. Within 90 minutes, he has gone to the bank, withdrawn funds, and wired the money to his suffering granddaughter or grandson. If she didn't sound just right on the phone, it's because of the tears or the wound to her mouth, or the bad connection. And she'll be paying him back in just days, as soon as she gets home and the insurance pays.

Motivated by love, clouded perhaps by memory or physical infirmaries, the grandfather sits back and begins to worry. He calls other relatives to see if they have more information about the situation—and his granddaughter answers the phone at her home.

He has been duped by a con artist, a person who may never know the depth of love and caring that the grandfather has just exhibited, but that love has cost Floridians more than half-a-million dollars in the last calendar year as they have fallen victim to "The Grand-parent Scam."

## \*\*\*\*\* Hurricane Season is Here \*\*\*\*\*

With hurricane season underway, ensure you are prepared with information that will assist you and your families during times of crisis. We hope that you never have to face such a crisis but, if you do, the following information will be helpful to you and your family.

#### Preparing for a Hurricane

Hurricanes threaten our safety and livelihood, presenting significant threats of flooding and wind damage. Meteorologists continue to predict active hurricane seasons for the foreseeable future, as well as above-average probability of major hurricane landfalls. The best way to prevent harm and reduce property damage is to be aware of the dangers posed by storms and to be prepared.

#### Be prepared... develop a home emergency plan

To prepare for any natural disaster, it's a good idea to have an emergency kit on hand.

#### Have a family communication plan

Your family may not be together when disaster strikes, so plan how you will contact one another and review what you will do in different situations. If you have family outside the area, be sure to inform them of your plans. They will be worried and trying to contact you.

#### Checklist - What to do before the hurricane

- Port Learn the terms used by weather forecasters. Know the difference between "watches" and
  "warnings" a watch means that storm conditions are in the specified area, usually within 36 hours while
  a warning is usually within 24 hours
- Listen for local radio or television forecasts
- Ask your local emergency management office about community evacuation plans
- Talk to your family about hurricane issues
- Determine the needs of your family/neighbors that might need assistance in a hurricane
- Prepare to survive on your own for at least three days
- Make plans to secure your property
- Learn how to shut off utilities and where gas and water shutoffs are located
- Have your home inspected for compliance with local building codes
- Be sure trees and shrubs around your home are well trimmed
- Make a record of your personal property with pictures or videotapes
- Decide in advance where to go if you must evacuate your home. You might choose a friend's home, a
  motel or a shelter.
- Identify a safe evacuation route and alternate routes. Remember that roads may be crowded and that bridges or causeways may be under water.
- Stock plywood, nails and other items needed to board up windows to protect your home.
- Prepare for possible power outages by stocking up on such necessities as food and bottled water, as
  well as a first aid kit, a portable radio, warm clothing and clean blankets. In addition, keep a supply of
  flashlights and extra batteries handy, and avoid relying upon potential light sources, such as candles and
  kerosene lamps, since open flames can be hazardous.
- Keep your car fueled in case you have to evacuate, and store some bottled water, nutritious snacks and blankets in the trunk.
- Listen to local radio or television for the latest information and instructions for your area. Protect your windows with boards or shutters.
- Look around your property and reduce the threat of flying debris. This includes moving all outdoor items
  (patio furniture, garbage cans, garden tools) indoors and, if possible, removing any tree limbs that may
  be too close to your home, or appear to be diseased or damaged.

- Check mobile home tie-downs.
- Make arrangements for your pets. In the event you needed to be evacuated to a shelter, most shelters won't allow them. Animals that assist people with disabilities are permitted.
- If time permits, and you live in an identified flood zone, elevate furniture to protect it from flooding or, better yet, move it to a higher floor.
- If you need to leave your home, shut off the gas, water and electricity.

#### **Hurricane Shelter Information**

Brevard County strongly urges that a Public Shelter be used Only As A Last Resort. You will be more comfortable sheltering with friends, family or in commercial lodging. If you require Public Sheltering, please be familiar with your designated Primary Evacuation Shelter location and your planned route to that shelter. Shelter Route Signs have been posted to assist you.

If you plan to go to a shelter:

- Be sure to take enough food and supplies to last several days, including special diet foods, as food may
  not be readily available at the Shelter.
- Bring bottled water (2 qts/person/day) and other beverages/juices/soft drinks.
- Bring a manual can opener, eating utensils, paper plates, cups and napkins/paper towels.
- Infant formula/food/diapers.
- Have a 2 week supply of medications & First Aid Kit.
- Cash or Travelers Checks.
- Sleeping bags, blankets, pillows, folding chairs. BEDDING IS NOT PROVIDED IN PUBLIC SHELTERS.
- Personal hygiene items and changes of clothing.
- Flashlight, battery powered radio/TV and spare batteries, cards, games, books and toys.

Do Not Take Pets (except Guide Dogs), Alcoholic Beverages Or Weapons Of Any Kind To Public Shelters.

## **WELCOME NEW RESIDENTS**

The board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member.

A few reminders regarding our Covenants, for those who do not have a copy —

- 1. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management.
- 2. **Bulk Items:** You do not need to call Waste Management to schedule a pickup bulk items (including furniture). These items can be placed at the curb on Fridays. The truck that picks up the yard trash will make note of the address and return later in the day to pick up bulk items. They will be automatically picked up as long as nothing was longer than 4 ft.; the same as yard trash. information, contact Waste Management at 321-723-4455.
- 3. **Electronics:** You still need to call to arrange a special pick up for appliances and electronics.
- 4. Garbage is picked up on Tuesdays and Fridays. Recycling is picked up Wednesday. Garbage containers/recycling bins should not be placed at the curb until 5pm the night before pick up. Garbage containers/recycling bins must be stored as not to be visible from the street or adjacent property within sight distance of the lot.
- 5. If you are planning to paint your home or plan any exterior changes, please contact the Architectural Review Committee (ARC) for approval **BEFORE** starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval.

## **Yard Condition of Vacant Homes**

The Board has received numerous complaints about different properties within Wickham Forest that are not being properly maintained. The Board is working hard to identify and take action to ensure all homes within the subdivision are maintained properly. Sometimes we are successful in contacting the homeowner, responsible realtor, or finance company and are able to work with them to maintain the property. Unfortunately, there are some properties where we cannot reach the proper authority to resolve the issue.

While the Board will continue to attempt to identify the responsible person and resolve these issues, there is also another solution that can sometimes be effective. If the property is so overgrown or deteriorated that it is a safety hazard for kids in the neighborhood, please call Melbourne Code Enforcement and ask them to assist in taking care of the property.

In some cases, the Board has hired a company to cut the grass. But before that can be done, we have to contact our legal counsel and determine the best course of action. When possible, we do take legal action to recover any fees paid or fines assessed.



### Trespassing on Pebble Creek property

The Wickham Forest Board has been informed by the Pebble Creek homeowners association that Wickham Forest residents and/or guests have been trespassing on Pebble Creek ponds and property. Pebble Creek residents are going to call the police and file trespassing charges if the trespassing continues on their ponds and on their property.
