A timely message for WFHOA from the City of Melbourne. Change your lawn watering schedule. During Daylight Saving Time irrigation is limited to no more than two days per week on scheduled days. Residential irrigation is allowed on Wednesdays and Saturdays at address that end in an odd number or have no address and on Thursdays and Sundays at addresses that end in even number.. Nonresidential irrigation is allowed on Tuesday and Friday. For more information about watering restrictions, visit the <u>St. Johns River Water Management Website.</u>

Garbage and Garbage Containers: It has been brought to the attention of the WFHOA Board of Directors that some Homeowners are leaving garbage containers/recycling bins in view from the street or placing garbage at curbside before designated times. Please be mindful that there should not be VISIBLE TRASH CONTAINERS ON YOUR DRIVEWAY AND/OR FRONT YARD or SIDE YARD. (VIOLATION). Trash, refuse and garbage shall not be placed at curbside earlier than 5:00 p.m. on the evening before the scheduled pickup. REFER TO THE WELCOME NEW RESIDENTS ARTICLE-Page6

Please refer to the Declarations of Covenants and Restrictions for Wickham Forest Subdivision, Section 7.5: Miscellaneous Use Restrictions (STATE COVENANT).

a) Trash, garbage or other waste shall not be kept on any Lot except in sanitary containers or garbage compactor units. Garbage containers, if any, shall be kept in a clean and sanitary condition, and shall be so placed or screened as not to be visible from any road or adjacent property within sight distance of the Lot. Trash, refuse and garbage shall not be placed at curbside earlier than 5:00 p.m. on the evening before scheduled pickup. Nothing herein contained shall be construed to conflict with State, County or City Rules, Ordinances or Statutes. Notice of Violations letters are being sent out!!

To avoid a violation notice and possible fine, be sure to contact the board with notice that you have requested from Waste Management a special pick up for a large amount of waste.

You will find this addressed in most issues of the WF Newsletters as well as on the WF webpage.

The board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member.

A few reminders regarding our Covenants, for those who do not have a copy —

- 1. <u>Yard trash is picked up on Fridays.</u> Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Waste Management will NOT pick up any yard trash in plastic bags.
- Bulk Items: You do need to call Waste Management to schedule a pickup bulk items (including furniture).
 These items can be placed at the curb on Fridays. For information, contact Waste Management at 321-723-4455.
- 3. **Electronics:** You still need to call to arrange a special pick up for appliances and electronics.
- 4. Garbage is picked up on Tuesdays and Fridays. Recycling is picked up Wednesday. Garbage containers/recycling bins should not be placed at the curb until 5pm the night before pick up. Garbage containers/recycling bins must be stored as not to be visible from the street or adjacent property within sight distance of the lot. Only items in the recycling container will be picked up on Wednesday. Large loose items will be picked up on Friday, if you call Waste Management early in the week. Plastic bags do not recycle.
- 5. If you are planning to paint your home or plan any exterior changes, please contact the Architectural Review Committee (ARC) for approval **BEFORE** starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval.
- 6. Waste Management trucks are automated, maned by only one employee. Therefore, any trash articles NOT in the garbage bin WILL NOT be picked up. The driver is not supposed to leave his truck.

STREET PARKING: Our covenants state that street parking is NOT allowed except in special circumstances. Parking on the lawns is NEVER allowed (including the lawn between the sidewalk and street. It is not a covenant violation if you park your vehicle on the street the wrong way or block the sidewalk. However, it is a city ordinance violation and you are susceptible to ticketing by the Melbourne Police. If you are parked on the street, or over city sidewalks know you are at risk of being fined \$50 per day. There is no warning.

Parking on the streets and/or lawns has been such a problem in the past, creating safety for the entire neighborhood. There have been situations where ambulances, fire trucks, and/or garbage trucks have had trouble getting past cars parked in the street when on route.

While a vehicle parked on the grass doesn't impede traffic, it is listed as a violation under our parking covenants and therefor must be enforced as stringently as vehicles parked on the street. For homeowners with multiple vehicles occupying the driveway, juggling vehicles to keep them off the street is probably not easy. Other homeowners in similar situations have widened their driveways to alleviate their problem. If you decide to widen your driveway, please obtain approval from the ARC before beginning. The board will not be sending warning letters to homeowners who have received parking notices in the previous 12 months. The board will proceed directly to fines. This notice serves as a reminder to all homeowners to park in their garages or driveways.

Sidewalks, Driveways, Houses and Mildew:

It seems our Florida warm weather, accompanied by rain has increased the growth of mildew on sidewalks, driveways, roofs and houses. Not only do mildew and other stains impair the appearance of your property; when wet, mildew as well as leaves and acorns can become slippery, a potential danger for those walking by. Please check your property and remedy the issues. Please keep in mind that cleaning the sidewalks adjoining or on your property is the homeowners responsibility. The WF Board will have members coming thru to check out homeowner's property for mildew and mold on sidewalks, driveways, houses and roofs, soon, Notices of violations of these issues will be forthcoming.

Very dark mold and/or iron stains can be tenacious and difficult to remove. Several neighbors have reported that chlorine brushed on prior to pressure cleaning yields satisfactory results. Others report home improvements stores offer other solutions to cleaning concrete. Consider cleaning up any mildew or mold on the sidewalks, driveways, houses, or roofs that you may have on your property, while the weather is still nice.

SPRING CLEANUP:

Now would be a good time to spruce up your yard while the weather is not too hot. Keep the lawn in good order and repair with sodding, seeding, watering, mowing and edging. Fertilizing can be applied now, but remember it is illegal to apply fertilizers within 10 feet of any water body or to apply them if heavy rain is likely. You may use irrigation to water in the application of fertilizer.

Keep all trees and shrubbery pruned and remove weeds/grass in flower beds and replace dead or damaged vegetation. Be mindful of plants and grass growing over sidewalks, interfering with walkers. If you maintain your own yard, be sure to trim/edge the grass along the sidewalk.

It is *ILLEGAL* to blow grass clippings into the street, gutter, ponds, or any other type of water body. Instead by blowing them back into your yard it will allow nutrients to return to the soil. Blowing grass clippings into the street, gutter, or pond is prohibited by the City of Melbourne Fertilizer Ordinance (Section 27,, Article IV) and can cause issues with algae or pond scum. The property owner and the person responsible for violating the ordinance can be fined \$200.00.

Please keep in mind when mowing, weeding and trimming your yard to store the collected waste out of sight until Thursday 5:00 PM for the Friday pick up.
