Meeting convened at 7:08 PM Minutes of previous meeting approved

President's Report:

Dead trees and bees were removed from the entrance by Arbor Tech. The City does not currently require Brazilian Pepper trees to be removed by the property owner. Jim (Arbor Tech) indicated removal would have to include pulling out the roots, which would be very expensive and useless since the trees on the adjoining lot would creep back in.

In March we had a neighbor putting notes in other mailboxes. This happened a few years ago. I posted to Nextdoor that any communication from the board goes through the US mail. Ed Clark posted the fact that tampering with a mailbox is a felony. The activity has stopped, no further complaints.

Karen Geniti sent some garden ideas for the entrance. The board decided to send a thank you note and a small token of our appreciation. A time to review her plans at the entrance will be arranged for early May, with a possible visit to Valkaria Gardens for additional ideas/input.

The Welcoming Committee has started calling on new neighbors. They found that if they could submit a request on HOW letterhead they could collect better coupons and/or discounts from nearby businesses for the baskets. Letterhead will be provided.

The Board is looking for recruits to populate the appeals committee. It will involve a brief meeting so the HOA will be prepared should we need them in the future.

2nd VP Report:

Mildew/Mold/Stains checks are underway. The following violation letters were mailed: 39-Mildew/Mold/Stains; 12-Yard Trash; 5-Garbage cans/recycling bins, and 1-fine for non-compliance.

Homeowner-Mr. Sharman at 2600 Wild Wood Drive had his roof cleaned earlier this spring. He used All Pro Roof Cleaners, and he was very satisfied with the company. All Pro Roof Cleaner's phone number is: 321-633-3035.

The product called "Spray and Forget" is the best way to treat mold. It is applied with a hose end sprayer. It can take a few weeks to kill the mold and usually protects for a year. Pressure washing is not recommended.

**PET CARE-**When walking your dog, remember to pick up the waste and dispose of it properly. Leaving the waste on the ground increases public health risks by allowing harmful bacteria and nutrients to wash into the storm drains. Besides being inconsiderate to your neighbors, it is a violation of Melbourne Ordinance. Additionally, the Wickham Forest 2010 Covenants identifies failure to clean up after your pet as an infraction that can be assessed a fine of \$50.00 per violation if you are observed. (Section 7.5c).



# **Appeals Committee Members Needed:**

The Wickham Forest Homeowners Association is in need of additional Appeals Committee Members who might give a fair and balanced opinion if asked to do so during an appeals issue. (Appeals issues are rare with only three issues within the past 10 years). If you are interested in serving on this important committee and would like additional information on the responsibilities of this committee, please see a board member or send a request to wickham-forest@googlegroups.com. The board would like to consider you for this position.

The board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member.

A few reminders regarding our Covenants, for those who do not have a copy —

- 1. <u>Yard trash is picked up on Fridays.</u> Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Waste Management will NOT pick up any yard trash in plastic bags.
- Bulk Items: You do need to call Waste Management to schedule a pickup bulk items (including furniture).
  These items can be placed at the curb on Fridays. For information, contact Waste Management at 321-723-4455.
- 3. **Electronics:** You still need to call to arrange a special pick up for appliances and electronics.
- 4. Garbage is picked up on Tuesdays and Fridays. Recycling is picked up Wednesday. Garbage containers/recycling bins should not be placed at the curb until 5pm the night before pick up. Garbage containers/recycling bins must be stored as not to be visible from the street or adjacent property within sight distance of the lot. Only items in the recycling container will be picked up on Wednesday. Large loose items will be picked up on Friday, if you call Waste Management early in the week. Plastic bags do not recycle.
- 5. If you are planning to paint your home or plan any exterior changes, please contact the Architectural Review Committee (ARC) for approval **BEFORE** starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval.
- 6. Waste Management trucks are automated, maned by only one employee. Therefore, any trash articles NOT in the garbage bin WILL NOT be picked up. The driver is not supposed to leave his truck.

## Sidewalks, Driveways, Houses and Mildew:

It seems our Florida warm weather, accompanied by rain has increased the growth of mildew on sidewalks, driveways, roofs and houses. Not only do mildew and other stains impair the appearance of your property; when wet, mildew as well as leaves and acorns can become slippery, a potential danger for those walking by. Please check your property and remedy the issues. Please keep in mind that cleaning the sidewalks adjoining or on your property is the homeowners responsibility. The WF Board will have members coming thru to check out homeowner's property for mildew and mold on sidewalks, driveways, houses and roofs, soon, Notices of violations of these issues will be forthcoming.

Very dark mold and/or iron stains can be tenacious and difficult to remove. Several neighbors have reported that chlorine brushed on prior to pressure cleaning yields satisfactory results. Others report home improvements stores offer other solutions to cleaning concrete. Consider cleaning up any mildew or mold on the sidewalks, driveways, houses, or roofs that you may have on your property, while the weather is still nice.

### **SPRING CLEANUP:**

Now would be a good time to spruce up your yard while the weather is not too hot. Keep the lawn in good order and repair with sodding, seeding, watering, mowing and edging. Fertilizing can be applied now, but remember it is illegal to apply fertilizers within 10 feet of any water body or to apply them if heavy rain is likely. You may use irrigation to water in the application of fertilizer.

Keep all trees and shrubbery pruned and remove weeds/grass in flower beds and replace dead or damaged vegetation. Be mindful of plants and grass growing over sidewalks, interfering with walkers. If you maintain your own yard, be sure to trim/edge the grass along the sidewalk.

It is *ILLEGAL* to blow grass clippings into the street, gutter, ponds, or any other type of water body. Instead by blowing them back into your yard it will allow nutrients to return to the soil. Blowing grass clippings into the street, gutter, or pond is prohibited by the City of Melbourne Fertilizer Ordinance (Section 27,, Article IV) and can cause issues with algae or pond scum and it also violates the WFHOA covenants and is subject to a fine. The property owner and the person responsible for violating the ordinance can be fined \$200.00.

Please keep in mind when mowing, weeding and trimming your yard to store the collected waste out of sight until Thursday 5:00 PM for the Friday pick up.
