## **NEW PROCEDURE FOR REPORTTING VIOLATIONS**

The covenants stipulate that the Wickham Forest Homeowner Board of Directors is responsible to uphold the covenants. Two board members verify a violation before a notice is sent to a homeowner.

Mildew/mold or any type of stain on homes, roofs and sidewalks; homes needing painting, lawns needing to be mowed and edged, trees needing to be pruned; planting beds needing to be weeded <u>WILL NOT</u> require a photograph to be taken because they are obvious enough just by looking that they are not going to be taken care overnight.

Trash cans, yard waste at the curb early, illegally parked cars; things that can change overnight <u>WILL NEED</u> a photograph to be taken in order to establish a pattern or to prove a continuous violation.

Board members will be the ones taking photographs to verify violations!



# **IMPORTANT Yard Waste Reminder**

Yard waste is collected by the City on <u>Friday</u>. Wickham Forest covenants regarding yard waste have not changed. Trash and yard waste shall not be placed at curbside earlier than <u>5:00 p.m.</u> on Thursday, the evening before scheduled pick up. It only takes a few moments to haul a garbage can to the curb.

# **VIOLATION LETTERS WILL BE SENT:**

If you have telephoned the City for pick up, please take a moment to notify the Board so you do not receive a violation notice.

If very large amounts of yard waste need to be removed, the city should be called (321-953-6302) as located on page 7 of this newsletter to schedule a special pick up. If you hire someone to trim your trees/shrubs they are REQUIRED to haul the debris away. Unlicensed/uninsured vendors may not provide complete service and could present possible legal problems for the homeowner.

- 1. Complaint followed by minimum of two board members verifying with dated picture as needed.
- 2. Reminder allowing ample time to correct the violation.
- 3. 2nd Notice again allowing ample time to correct the violation.
- 4. 3rd Notice again allowing ample time to correct violation.
- 5. 14 days notice to communicate with the Appeals Committee if in agreement with the fine.
- 6. Appropriate fines administered should the violation NOT be corrected.

A FRIENDLY REMINDER: The ARC Committee is unable to consider requests for painting <u>without a color sample</u>. We cannot take just a name or "same as before." Requests submitted without proper documentation just delay the approval of your request.

### Our next meeting will be September 12, 2017, 7:00 PM., at 4590 Willow Bend Drive

Most items are easily approved and most questions answered. We are all working to make our Wickham Forest neighborhood the best and loveliest in the area. All projects must be started within 6 months or a new request will have to be submitted. Also, remember to check with the covenants or the ARC member if you have any questions regarding exterior changes.

### Notice to Wickham Forest Residents:

It is <u>highly unusual</u> that a person representing the Wickham Forest Board of Director of Directors would knock on your door for anything, especially a violation. Again, when violations are reported to the board, a minimum of 2-3 board members verify that the report is authentic, then a violation notice is **MAILED** via USPS. Board members may walk past your property, drive past your property and/or at times take a dated photo for documentation to confirm that there is, indeed a frequently occurring violation.

If you receive a typed or printed notice on your door or auto, it will **NOT** be left by a person representing the WFHOA Board of Directors. If a written message is left in your mailbox without a postage stamp, it is a violation of federal postal codes and punishable by law and you should notify the proper authorities as well as notifying the board so everyone can be vigilant.

It is the hope and expectation of this board that everyone in Wickham Forest is striving to keep their property in the very best of condition at all times.

### **WELCOME NEW RESIDENTS**

The board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member.

A few reminders regarding our Covenants, for those who do not have a copy —

- 1. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Waste Management will NOT pick up any yard trash in plastic bags.
- 2. **Bulk Items:** You do need to call Waste Management to schedule a pickup bulk items (including furniture). These items can be placed at the curb on Fridays. The truck that picks up the yard trash will make note of the address and return later in the day to pick up bulk items. They will be automatically picked up as long as nothing was longer than 4 ft.; the same as yard trash. information, contact Waste Management at 321-723-4455.
- 3. **Electronics:** You still need to call to arrange a special pick up for appliances and electronics.
- 4. Garbage is picked up on Tuesdays and Fridays. Recycling is picked up Wednesday. Garbage containers/recycling bins should not be placed at the curb until 5pm the night before pick up. Garbage containers/recycling bins must be stored as not to be visible from the street or adjacent property within sight distance of the lot. Only items in the recycling container will be picked up on Wednesday. Large loose items will be picked up on Friday.
- 5. If you are planning to paint your home or plan any exterior changes, please contact the Architectural Review Committee (ARC) for approval **BEFORE** starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval.
- 6. Waste Management trucks are automated, maned by only one employee. Therefore, any trash articles NOT in the garbage bin WILL NOT be picked up. The driver is not supposed to leave his truck.

## ARC GUIDELINES

The HOA board understands that trends in house colors have changed over the years and so is working on updating the official color book. The guidelines used by the ARC for evaluating color schemes essentially remains intact, conforming to the guidelines in the Official Color Book for house, trim and accent (i.e. the front door). The selected colors need to be considered in relation to:

Roof color Any brick or stone color Colors of adjacent homes Compatibility of house and trim colors

When submitting a request for house painting to the ARC the homeowner needs to include:

Color name, number and manufacture (if your color choice is already on a home somewhere in the neighborhood, the ARC chair-person can provide you with this information) along with a sample of colors attached to the form.

Color garage door is to be painted

Fascia, soffit and rain gutter color, if applicable (generally, these are left white, unless the trim is a pale neutral that matches the roof)

Front Door color, if applicable

In most cases, if new or unusual color combinations are being requested, samples of such color will need to be painted on the house so they can be evaluated for confirmation to the standards. A tiny swatch of color in the paint store under fluorescent light may seem lovely, however, when it covers a whole house it can become overwhelming.

Some helpful tips when preparing to select house colors: Use non pastel shades and tones of a color look better with a white or cream trim.

Garage doors are not considered trim and should generally be painted the house color (doing so tends to make the house look larger) with the exception of:

If the house is a deeper tone with white trim, the garage door can be the trim color.

If the house is painted a light and medium shade of a single color (i.e. a light grey and a medium grey) the garage door can be painted the trim color.

Houses with double trim bands:

Paint both bands the same color

Paint them two shades of the same color

Do not paint unrelated colors.

### What are My Recyclables Used to Make?

Besides the items shown in the graphic, your recycling efforts really do pay off in abundance. Here is a run down of some of the most commonly recycled items and what they are made into after they have been collected at the curb:

#### Aluminum Cans

Aluminum cans are shredded, cleaned, melted and mixed with a pure aluminum base, then recast into new aluminum products.

#### Aluminum Foil/Trays

Foil packaging can be made into new wrapping foil, semirigid packaging such as pie plates and food trays, and flexible packaging such as gum or candy wrappers.

# Paperboard Boxes (cereal, crackers, pasta, cake boxes, etc.)

These boxes are generally used to make new boxes, puzzles and things such as egg cartons.

#### Cardboard

Cardboard can be recycled into new cardboard, paperboard boxes, puzzles, games and items such as tablet backing.

#### Glass Bottles and Jars

Old food and beverage containers are crushed into a material called cullet and made into new food and beverage containers. Some kinds of glass are made from different ingredients than glass bottles and jars. For instance, window glass, drinking glasses, dishes and mirrors are all made differently. Therefore, they cannot be recycled at the curbside with glass bottles and jars.

Magazines, Catalogs and Phone Books These are recycled into items such as food or gift boxes, tissue paper, game boards and greeting cards.

#### Mail, Office and School Paper

These papers can be used to make cereal boxes, facial and tollet paper, greeting cards, gift wrap and writing paper.

#### Newspapers

Newspapers and inserts are mixed in with other grades of paper to make new newspapers, paperboard; puzzles, wallboard, gift/food boxes and animal bedding.

Plastic Containers with Necks, #1 and #2 PETE #1 is recycled into carpet, clothing, strapping, tennis balls and other bottles. HDPE #2 is recycled into new containers, drainage pipe, film, pallets and plastic lumber for picnic tables, decks and fencing.

#### Steel Food Cans

The two by-products — high grade steel pellets and tin ingots — are both remade into tinplate containers. Most steel cans are used to make new cans for food products, paint, aerosol and other materials.
