December WFHOA Board of Directors meeting minutes.

The meeting was called to order at 7:06 PM with a quorum in attendance:

Mary Greenfield, Ed Clark, Kevin Rozanski, Nancy Phillips, and Ashley Bumgarner

Meeting attended by Administrative assistant, and 2 WF Residents.

- 1. Mary puts forth motion to accept the minutes from the last meeting. Keven seconded, unanimously carried.
- 2. Ed reported to the board that unplanned expenses for ponds and swales significantly impacted reserve funds. Ed presented two options for the 2019 Annual Budget, one with a 15% dues increase and one without. Both options included new line items for maintenance that were previously unbudgeted. Ed put forth a motion to raise dues by 15% in 2019, seconded by Mary, and unanimously carried.
- 3. The November treasurer report was presented. Mary made a motion to accept, seconded by Ashley, and unanimously carried.
- 4. A discussion to install inexpensive reflectors on the islands on Forest Run Dr was held. A motion was put forth by Ashley for reflectors to be purchased and installed by the Board to minimize expense. Nancy seconded, unanimously carried.
- 5. Mary briefed the outcome of the Board's decision to terminate the existing landscaping contractor and collect new bids. Of the bids collected, ProLawn was selected to start a two-year contract in January 2019.
- 6. Violation numbers from October were shared by Kevin.

7. Nancy made a motion to adjourn the meeting, seconded by Mary. The meeting adjourned at 7:44 P.M.

Welcome New Residents!

The board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any board member at wickham-forest@googlegroups.com.

A few reminders regarding our Community and Covenants:

- 1. Garbage is picked up on Tuesdays and Fridays. Recycling is picked up Wednesday. Trash, garbage or other waste shall not be kept on any Lot except in sanitary containers or garbage compactor units. Garbage containers, if any, shall be kept in a clean and sanitary condition, and shall be so placed or screened as not to be visible from any road or adjacent property within sight distance of the Lot. Trash, refuse and garbage shall not be placed at curbside earlier than 5:00 p.m. on the evening before scheduled pickup.
- 2. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Waste Management will NOT pick up any yard trash in plastic bags.
- 3. For Bulk Items: Contact Waste Management to schedule a bulk items pick up (including furniture). These items can be placed at the curb on Fridays. The truck that picks up the yard trash will return later in the day to pick up bulk items. For more information contact Waste Management at 321-723-4455.
- 4. Waste Management trucks are automated, maned by only one employee. Therefore, any trash NOT in the garbage bin WILL NOT be picked up.
- 5. If you are planning to paint your home or plan any exterior changes, to include Roofs and Fences, please contact the Architectural Review Committee (ARC) for approval BEFORE starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval, regardless of the current color.
