There have been increased numbers of <u>solicitors</u> in local neighborhoods, including Wickham Forest. Our community is a "no soliciting" neighborhood as indicated on the entrance sign. Of course, children known to you are always welcome to speak to you about their school, Scouts, or sports fundraising. BUT, if you are approached at your door, or while working outside by unknown adults, please remind them that Wickham Forest does not allow soliciting. Even a City of Melbourne permit to solicit does not apply in this neighborhood. If anyone says that they have 'Board approval', please know that the members of your HOA Board will NEVER give approval to solicit in Wickham Forest. If after leaving you they move along to another home, please don't hesitate to call the NON-emergency police number to report. They need to follow the rules!

Please remember to <u>PICK UP after your dogs</u>. Residents are required to pick up any deposits made by your pets when walking them in the neighborhood. Not only is it an offense to other residents, but this is also a City ordinance! NEVER put the waste into the storm drains, as that leads directly to the Indian River Lagoon and causes damage to that delicate ecosystem, including algae blooms. We need to help protect our Florida wildlife!! Letters will be sent to homeowners regarding observed violators.

January 2023 Board Meeting

Minutes

Nancy called the meeting to order at 7:03PM with a quorum of all five Board members present.

Secretary's minutes from the meeting in November were approved as published in the December newsletter. Financial reports since November meeting were approved as published in the December and January monthly newsletters.

There is no update from the City of Melbourne on the total closure of the Wild Wood bike path.

Purchasing chain link fencing to repair the vandalized Wild Wood bike path even though it will be more than needed for a repair. A homeowner volunteered to store the extra fencing in case additional repairs are required due to vandalism. The homeowner who volunteered to install the fence repair will be contacted as soon as the purchase is complete.

Dead plants in the east island on Forest Run were removed by the landscaper. Croton plants were planted to replace them, but a few more are needed. Nancy will purchase them and have them planted as soon as possible. The land-scaper will water and care for the new plants. A homeowner on Forest Run next to the island has also agreed to water the new plants weekly to ensure success.

The Board will do further research on whether additional liability insurance is needed to cover tasks completed by Board members and other homeowner volunteers. Costs for coverage versus not covering will be evaluated.

Plans were discussed for the Annual Meeting next month, on Wednesday, February 15th at Joe's Club. Sign-in will begin at 6:30. The Board will contact volunteers to count the ballots that night for the 2023 Board of Directors, and results will be announced at the meeting.

The monthly ARC meeting for February will be held at 6pm that night so that ARC members can participate in the Annual Meeting following their meeting.


ECOR has been called regarding complaints of excessive algae and grass in the Wood Haven pond. Water levels are high due to the heavy rains from the hurricanes. A homeowner present at the meeting said that the Forest Run pond also has algae present. ECOR evaluates and takes appropriate action.

Homeowners Elise on Wood Haven and Jane on Forest Run will be asked to coordinate scheduling of the spring Yard/Garage Sale. Both of these ladies are regular participants and use these sales to benefit charitable organizations.

A letter was received from a homeowner near the Willow Bend/Bent Pine intersection requesting a four-way stop at that intersection. Some drivers are not coming to a stop before proceeding through the intersection. The homeowner's concern is that there are two public school buses that stop there twice a day, and it is a safety hazard. This will be referred to the Melbourne Police Department and traffic engineer since the Board has no jurisdiction regarding stop signs on public roads.

The meeting was adjourned at 7:44PM.

Welcome New Residents!

The WF Board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any Board member at: wickham-forest@googlegroups.com.

A few reminders regarding our Community and Covenants:

- 1. Garbage is picked up on Tuesdays and Fridays. Recycling (yellow lid) is picked up Wednesdays. Trash, garbage or other waste shall not be kept on any Lot except in sanitary containers or garbage compactor units. Garbage containers, if any, shall be kept in a clean and sanitary condition, and shall be so placed or screened as not to be visible from any road or adjacent property within sight distance of the Lot. Trash, refuse and garbage shall not be placed at curbside earlier than 5:00 p.m. on the evening before scheduled pickup.
- 2. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Waste Management will NOT pick up any yard trash in plastic bags. If you have very large piles of branches and clippings, always call Waste Management ahead of Friday pickup to notify that you have a large amount. ALSO CALL DAVID AMBROSE—City of Melbourne Manager of the Waste Management contract. (321) 608-5081.
- 3. For Bulk Items: Contact Waste Management to schedule a bulk items pick up (including furniture). These items can be placed at the curb on Fridays. The truck that picks up the yard trash will return later in the day to pick up bulk items. For more information contact Waste Management at 321-723-4455.
- 4. Waste Management trucks are automated, manned by only one employee. Therefore, any trash NOT in the garbage bin WILL NOT be picked up.
- 5. If you are planning to paint your home or plan any exterior changes, to include Roofs and Fences, please contact the Architectural Review Committee (ARC) for approval BEFORE starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval, regardless of the current color. Applications for ARC approval are available on the website at wickhamforest.com
