The Board has received numerous reports of alligators in the ponds of Wickham Forest. Last month, an article in the newsletter reminded homeowners and residents what to do if you encounter an alligator in or near your property. This included how to safely move away from the beast, and phone numbers you can access to contact authorities regarding a nuisance alligator.

<u>Every Floridian</u> needs to be aware that alligators DO live in the same habitats as humans. They are not restricted to the Florida Everglades and wetlands. Alligators are attracted to any water source - fresh-water lakes, ponds, and even brackish waters, and do occasionally breach screened-in pool enclosures. Alligators are opportunistic feeders. Their diets include prey species that are abundant and easily accessible. Juvenile alligators eat primarily insects, amphibians, small fish, and other invertebrates. Adult alligators eat fish, snakes, turtles, <u>small mammals</u>, and birds.

With all that being said, the WF Board President, Nancy Phillips asks all residents to heed this advice. "Wickham Forest residents and visitors: Assume that alligators are or can be in every body of water in Florida, including screened swimming pools. Gators will go anywhere they sense water! Please be alert at all times."

The Board will not send out danger warnings every time a gator is spotted in one of our ponds in Wickham Forest. It is up to every resident to be aware of the wildlife that shares our habitat and take appropriate caution with small children and pets at all times.


Our next meeting will be January 17, 2024 at 7:00 P.M. at Joe's Club

Welcome New Residents!

The WF Board would like to welcome you to the community. If you do not have a copy of our Covenants and Deed Restrictions, or have any questions about them, please contact any Board member at: wickham-forest@googlegroups.com.

A few reminders regarding our Community and Covenants:

- 1. Garbage is picked up on Tuesdays and Fridays. Recycling (yellow lid) is picked up Wednesdays. Trash, garbage or other waste shall not be kept on any Lot except in sanitary containers or garbage compactor units. Garbage containers, if any, shall be kept in a clean and sanitary condition, and shall be so placed or screened as not to be visible from any road or adjacent property within sight distance of the Lot. Trash, refuse and garbage shall not be placed at curbside earlier than 5:00 p.m. on the evening before scheduled pickup.
- 2. Yard trash is picked up on Fridays. Yard trash should not be placed at the curb until the night before pick-up. Tree branches/shrub clippings, etc. need to be cut down to 4 foot sections and bundled for easier pick up by waste management. Waste Management will NOT pick up any yard trash in plastic bags. If you have very large piles of branches and clippings, always call Waste Management ahead of Friday pickup to notify that you have a large amount. ALSO CALL DAVID AMBROSE—City of Melbourne Manager of the Waste Management contract. (321) 608-5081.
- 3. <u>For Bulk Items</u>: Contact Waste Management to schedule a bulk items pick up (including furniture). These items can be placed at the curb on Fridays. The truck that picks up the yard trash will return later in the day to pick up bulk items. For more information contact Waste Management at 321-723-4455.
- 4. Waste Management trucks are automated, manned by only one employee. Therefore, any trash NOT in the garbage bin WILL NOT be picked up.
- 5. If you are planning to paint your home or plan any exterior changes, to include Roofs and Fences, please contact the Architectural Review Committee (ARC) for approval BEFORE starting any new project. A sample of paint color, shingle type/color, plan layout, etc. must be submitted to the ARC for approval, regardless of the current color. Applications for ARC approval are available on the website at wickhamforest.com
- 6. In case you haven't heard, Wickham Forest residents have a great opportunity to stay informed with what is happening in our subdivision, as well as in the surrounding area.
